ATTENTION SUWANNEE ASSOCIATION MEMBERS!

According to Article IV, Paragraphs three, four and five of our Bylaws a Special Meeting of the Suwannee Holiness Camp Association has been called by the President and Board of Directors for **Saturday, April 24, 2010 at 01:00pm** for the purpose of voting on a change to paragraph one of Article Seven of the By-Laws.

CURRENT ARTICLE VII PARAGRAPH ONE READS:

The business of this organization shall be managed by a Board of Directors consisting of not less than 12 including all the officers of this organization. At least 80% of the members of the Board shall be members of the Church of the Nazarene in good standing.

PROPOSED ARTICLE VII PARAGRAPH ONE CHANGES:

The business of this organization shall be managed by a Board of Directors consisting of not less than 15 members including all the officers of this organization. At least 60% of the members of the Board shall be members of the Church of the Nazarene or a sister denomination that is in harmony with Article Three of the Associations Articles of Incorporation.

Article III of the Articles of Incorporation reads in part:

PURPOSES AND ARTICLES OF FAITH

- a. The specific and primary purpose for which this corporation is organized shall be to conduct religious camps, retreats, seminars, workshops for families, adults, youth and children to advance spiritual growth and enlightenment, moral and personal purity, physical and intellectual development for all who attend; to preach the gospel of Jesus Christ in order to lead all who attend into a personal knowledge of the saving and sanctifying grace of God as it is in Christ Jesus, to build up the believers in their most holy faith; and for the purpose of promoting the foregoing object, this corporation shall have the right to acquire, either by gifts or purchase, and to hold, own, sell, mortgage, or encumber in any manner, lease and improve real estate and personal property for itself and others.

The Articles of Faith of this corporation are as follows:

- (a) We believe in God the Father, Son, and the Holy Spirit. We especially emphasize the deity of Jesus Christ and the personality of the Holy Spirit.
- (b) We believe that man is born in sin; that he needs the work of forgiveness through Christ and the new birth by the Holy Spirit; that subsequent to this there is the deeper work of heart cleansing or entire sanctification through the infilling of the Holy Spirit, and to each of these works of grace the Holy Spirit gives witness.
- (c) We believe that our Lord will return, and the dead shall be raised, and that all shall come to final judgment with its rewards and punishments.
